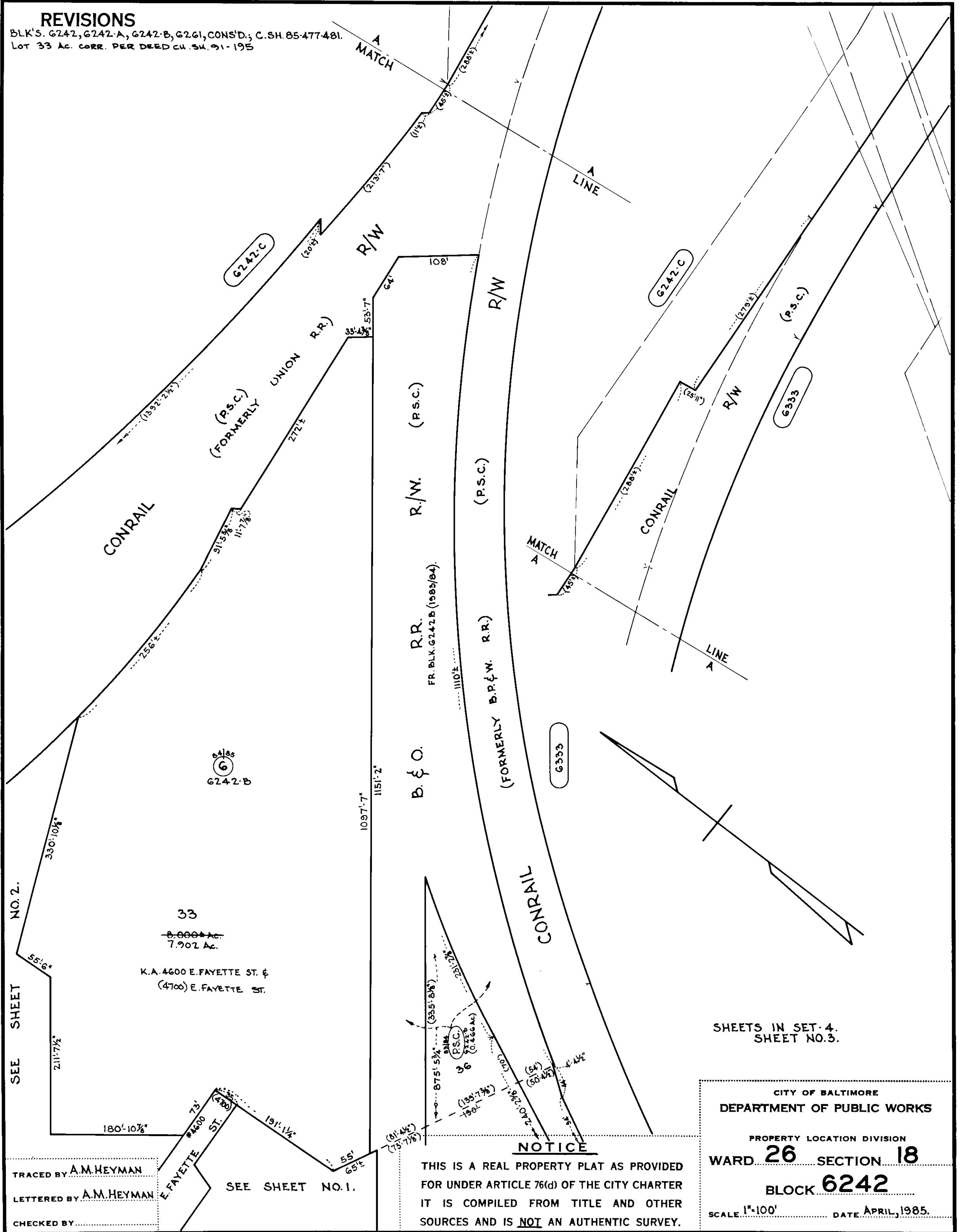

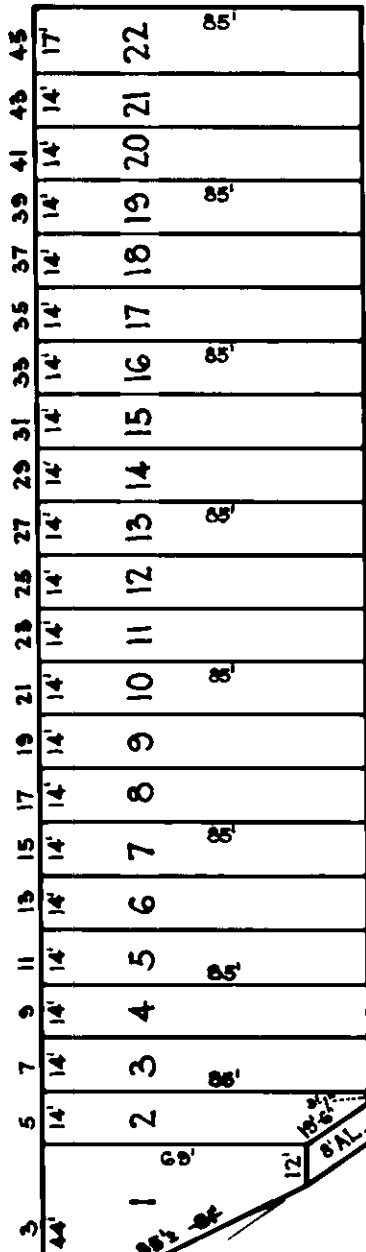

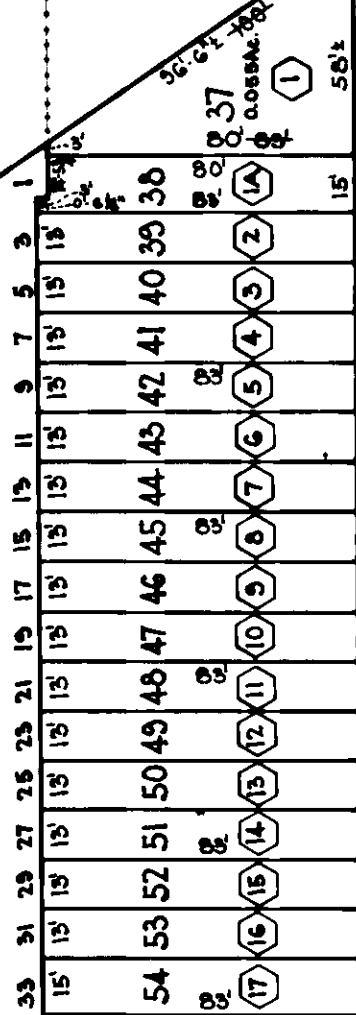

SUB-PLAN FROM SHEET NO. 1.

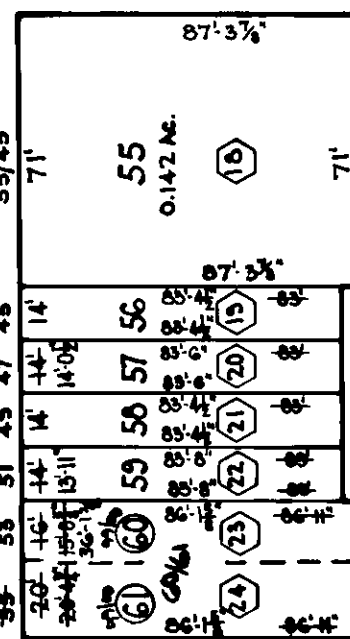
